

# Message from the NJSIAA Chief Compliance Officer

On January 18th, the NJSIAA Executive Committee voted to allow new transfer and recruiting rules to move forward in its approval process. The rules were submitted to the Executive Committee by its Advisory Committee in November and moved forward for feedback from athletic directors, leagues, and conferences throughout the State. Final versions of the rules will be voted on by full membership later this spring.

The NJSIAA Transfer Committee, made up of principals and superintendents, was tasked with examining all aspects of its current, much maligned, transfer and recruiting rules. The committee gathered data related to transfers, examined its current rules and practices, gained input from ADs, coaches associations, its Diversity Equity and Inclusion Committee, the Commissioner of Education, leagues and conferences and its Executive Committee. The NJSIAA has concluded its yearlong initiative by proposing new transfer and recruiting rules that it believes truly provides a level playing field for all student-athletes across all NJSIAAmember schools.

The proposals remove the need for a bona fide change of address and no longer relies on varsity participation status when determining a studentathletes eligibility. The new rules would grant student-athletes one penalty-free transfer during the first 6 semesters of their high school career, provided that the transfer occurs prior to the start of the season. Studentathletes who transfer a second time (and any subsequent transfers), will be subject to the 30-day sit (or ½ the number of max. contests) for all NJSIAA sanctioned sports which the student-athlete participated in during the previous 12 months. Seniors who are transferring for the first time will be subject to a lesser penalty. The recruiting rule will focus on recruiting of high school athletes, not athletes from grades K-8. Penalties would stiffen and focus on the coaches and schools, not students, who are in violation of contacting and recruiting athletes from other high schools.

## Do I need to submit a standardized test score to the NCAA?

As of January 2023, standardized test scores are **not required** for **all** student-athletes who initially enroll full time on or after August 1, 2023. During the 2023 NCAA Convention, Divisions I and II adopted legislation to remove standardized test scores for these students. The vote was based on the recommendation from the Standardized Test Score Task Force, a specialized group charged with reviewing initial-eligibility requirements as part of the NCAA's eight-point plan to advance racial equality.

Among other requirements, college-bound student-athletes planning to compete at an NCAA Division I or II school are still required to have a 2.3 (DI)/2.2 (DII) grade point average in 16 NCAA-approved core-course units and provide proof of high school graduation. •Division III: Student-athletes planning to attend a Division III school are not required to have an academic certification from the Eligibility Center but may be required to have an amateurism certification. http://fs.ncaa.org/Docs/eligibility\_center/Student\_Resources/DIII\_Amat.pdf

### REMEMBER WHEN BY BOB GRACE

Our Executive Director Emeritus, Mr. Frank Baldachino, has put together an impressive compilation of the chronology and history of the Directors of Athletics Association of New Jersey. Below you will find a synopsis of four randomly selected years in the seventy one year history of our association. In future editions of our Newsletter we will continue to bring you information on several more years in our long and storied history.

### **1960**

Virgil Sasso of Fair Lawn High School was the President of the DAANJ. The annual Workshop was a one day outing held at Fairlawn High School. The one day format included speakers on various topics.

### **1972**

Richard Lansing of Point Pleasant Boro High School was the President of DAANJ. The annual Workshop was a two day format , held at the Colony Motel in Atlantic City on March 21st & 22nd. There was no Keynote Speaker in 1972, only group discussions on some of the following topics; "Managing an Athletic Program", "Role of the Director of Athletics in the Negotiating Process", Accountability in Athletic Supervision", and "Current Concerns at Athletic Contests". Seven Retirees were honored in 1972 and there were 12 Exhibitors at the Workshop.

### **1978**

Bob Feeney of Shore Regional High School was the President of DANJ. The annual Workshop had just moved to the Tamiment Country Club, in the Poconos, and was designed as a 3 day format, from March 20th to 22nd. The Theme of the Workshop was "Preparing for the 80's". Rev. Angelo Palermo, Principal, Bishop Eustace High School was the Keynote Speaker, his topic, 'Preparing for the 80's'. Five Retirees were honored at the Awards Banquet, along with "Athletic Director of the Year", Ben Maggio of Plainfield High School. There were 18 Exhibitors at the Workshop.

### 1989

George Maier of Haddon Township High School was the President of DAANJ. The annual Workshop was a four day format, held at Trump Plaza from March 20th to 23rd. Donny Conn, LosAngeles, California was the Keynote Speaker, his topic, 'We are the Best Business, You and I'. Seventeen Retirees were honored in 1989 at the Awards Banquet. Robert Hopek of North Hunterdon Reg. High School was honored as the "Athletic Director of the Year". There were 37 Exhibitors at the Workshop.

### NIAAA Certification Requirements for the CAA and CMAA Designation

The DAANJ has set a goal for 2023 to have a minimum of 23 new CAA Certification for our New Jersey Athletic Administrators. For our members who have not yet started on the road to NIAAA Certification we have laid out the requirements for both the CAA and CMAA

#### **CAA & CMAA Certification Requirements**

### CAA

### **Requirements:**

- Bachelor's Degree or higher from an accredited institution
- Two (2) or more years of experience as an athletic administrator
- Employed or retired from a school, school district or state athletic administration association, or state athletic/activities association in such capacity that the administration of interscholastic athletics is (was) among one's job responsibilities
- Completion of NIAAA Leadership Training Courses 501, 502, 503, 504 and 506. College and University course work will not be accepted unless the curriculum incorporates the entire content of the required Leadership Training Course
- Obtain the verifying signature of a principal, superintendent or state athletic administrators association executive director
- Read and abide by the NIAAA Code of Ethical and Professional Standards
- Candidate must provide copy of course completion certificates before taking the CAA exam, or submit an NIAAA transcript available through the membership portal
- Approval of Personal Data Form (PDF)
- Successfully complete the CAA Exam

### CMAA

### **Requirements:**

- Bachelor's Degree or higher from an accredited institution
- Have attained CAA designation
- Approval of Personal Data Form (PDF)
- Employed or retired from a school, school district, state athletic administrator association or state athletic/activities association in such capacity that the administration of interscholastic athletics is (was) among one's job responsibilities
- All requirements and PDF credits earned since CAA designation, except for leadership training courses
- Submission of supporting documentation

- Completion of NIAAA Leadership Training Courses 501, 502, 503, 504, 506, 508, and 510. College and university course work will not be accepted unless the curriculum incorporates the entire content of the required Leadership Training Course
- Completion of minimum of five (5) LTI electives (one course each from 600 and 700 categories and three courses from any level (500, 600, 700, 900)
- Completion of a graduate level written project or oral presentation
- Obtain the verifying signature of a principal, superintendent or state athletic administers association staff
- Read and abide by the NIAAA Code of Ethical and Professional Standards
- Candidate must provide copy of course completion certificates with PDF or submit an NIAAA transcript available through the membership portal
